MBC now provides automated connectivity between EG Group and its banks, increasing visibility and control over financial transactions by providing real-time notifications for tracking payments, approvals, and cash flow. The new enhancement means EG Group can now verify bank payments, debit and credit charges, cheques, track account fees, identify potential fraud, and track receivables faster. Another notable upgrade made as part of the project was Advanced Bank Statement Automation, which creates templates for reprocessing rules based on past patterns of manual actions during bank statement reprocessing.
